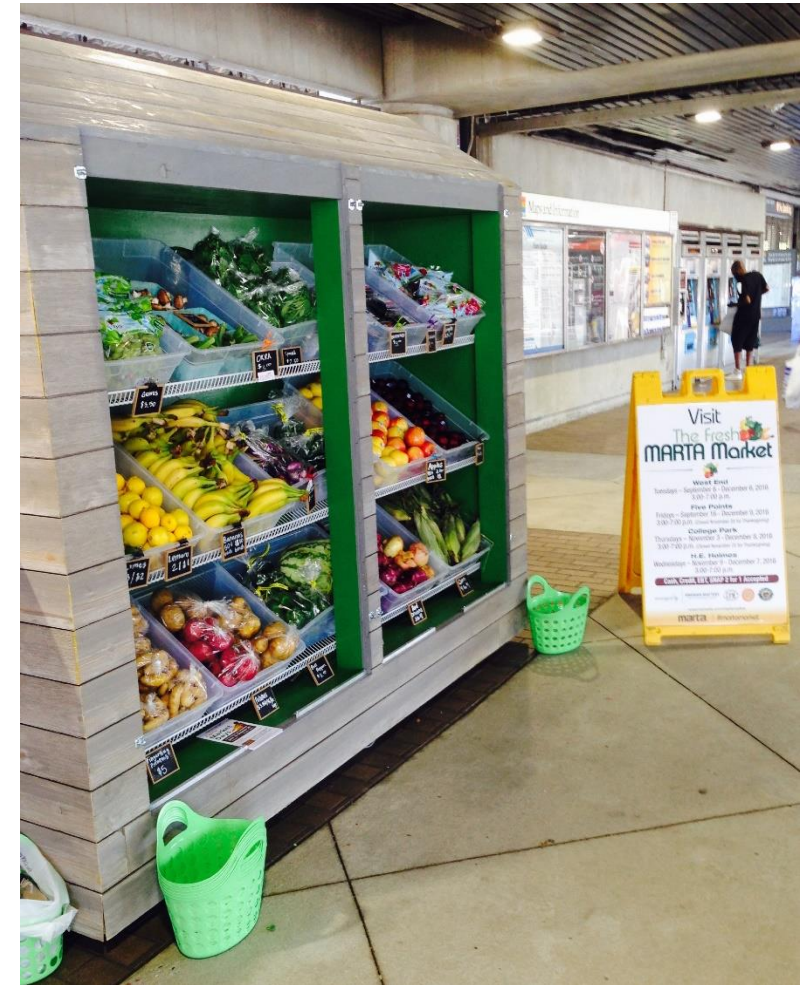
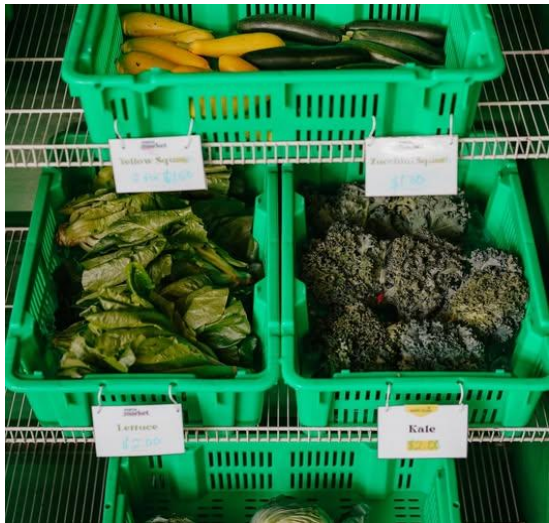


WHAT IS MARTA MARKET?

- ✓ **2021:** USDA awards \$851,677 for expansion

Statement of Qualification (AE) Process Timeline

- **November 16, 2023** - Planning & Capital Programs Committee briefed on use of qualifications-based selection process for Architectural & Engineering Final Design Services.
- **May 7, 2024** - Qualification Statements requested
- **June 20, 2024** - Qualification Statements were received from five (5) Architecture & Engineering firms which the Source Evaluation Committee (SEC) members independently reviewed and scored to determine a shortlist of two (2) firms.
- **September 10, 2024** - Oral interviews were conducted with the two (2) shortlisted firms.
- **November 13, 2024** - MARTA and the final vendor began negotiations.
- **February 25, 2025** - Reached an agreement.



Award Recommendation

The award recommendation is for **CDM Smith, Inc.** in the amount of \$27,711,997.85 with a DBE goal of 30%.

RESOLVED THEREFORE, by the Board of Directors of the Metropolitan Atlanta Rapid Transit Authority that the General Manager/CEO or his delegate be, and hereby is authorized to enter into a contract with CDM Smith, Inc. to provide Architectural and Engineering Design Services for Clayton County Southlake BRT Alignment and Airport Connectivity and is authorized to assign tasks by negotiated work orders that will not exceed the amount of \$27,711,997.85.

Project Scope and Schedule:

- Double crossovers allow trains to switch from one track to another
- Scope is for replacement of an aging double crossover (DXO) between Kensington Station and Indian Creek Station with a new No. 10 double crossover track
- Scope was originally in the Track Renovation IV contract which was terminated
- Along with the DXO replacement the system needs upgrades to signaling and power systems
- All scope of work is to preserve system reliability and maintain state of good repair

Why is a Modified Service Plan Required?

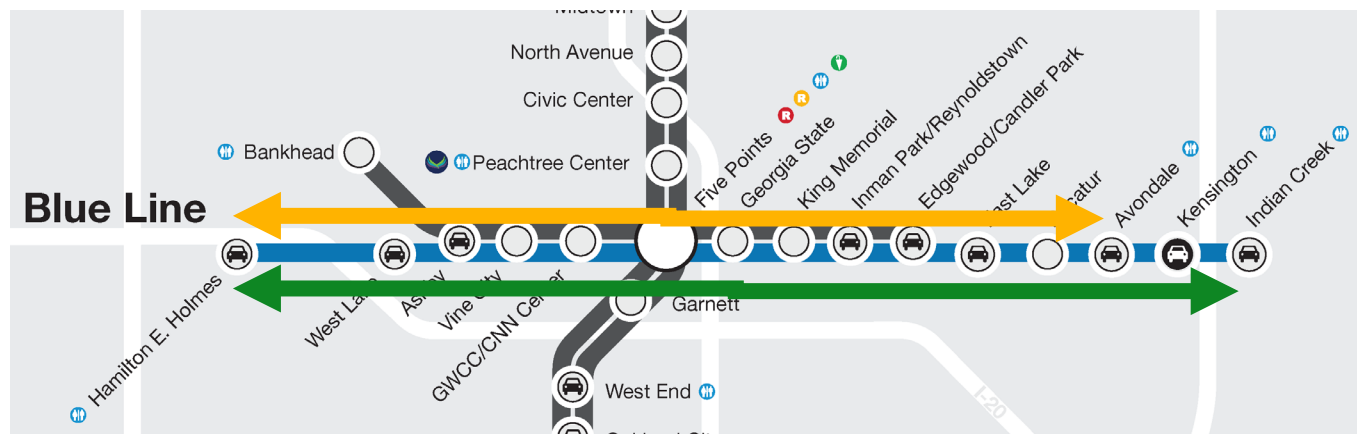
- Construction activities will require single tracking into and out of Indian Creek Station


